

## **DELEGATION AGREEMENT BYLAW**

### **HAMLET OF \_\_\_\_\_ BYLAW NUMBER \_\_\_\_\_**

A bylaw of the Hamlet of \_\_\_\_\_ (the "Hamlet") in the Northwest Territories pursuant to sections 64, 66 and 67 of the *Hamlets Act*, S.N.W.T 2003, C. 22 (the "*Hamlets Act*").

### **DELEGATION AGREEMENT**

1. The mayor and senior administrative officer are hereby authorized to enter into the Delegation Agreement that is attached as Schedule "A" to this Bylaw for and on behalf of the Hamlet.
2. The Delegation Agreement is hereby incorporated in, and forms a part of, this Bylaw.
3. For greater certainty, any power, duty or function of the Hamlet or its council that is not expressly delegated by this Bylaw shall remain with the Hamlet or its council, as applicable.
4. The Delegatee may not sub-delegate, to any person or entity, any authority or responsibility that has been delegated to it pursuant to this Bylaw.

### **SEVERABILITY**

5. Each provision of this Bylaw is independent of all other provisions. If a Court of competent jurisdiction declares any provision invalid for any

reason, all other provisions of this Bylaw shall remain valid and enforceable, and the Bylaw shall be interpreted as such.
